## RESOLUTION NO. 0206 Series of 2025

RESOLUTION APPROVING MUNICIPAL ORDINANCE NO. 2024-13-B OF THE MUNICIPALITY OF CALATRAVA, NEGROS OCCIDENTAL CREATING THE POSITION OF STATISTICIAN, SG 11 IN THE MUNICIPAL PLANNING AND DEVELOPMENT OFFICE

WHEREAS, thereby presented to the Board for review and appropriate action is Municipal Ordinance No. 2024-13-B of the Municipality of Calatrava, Negros Occidental creating the position of Statistician, SG 11 in the Municipal Planning and Development Office;

WHEREAS, the enactment of the subject ordinance finds legal support from the Local Government Code of 1991 (RA 7160), specifically Section 16 of the said Cod, also known as the "General Welfare Clause," which empowers Local Government Units to undertake activities and programs that promote the welfare of their constituents;

WHEREAS, every local government unit is clothed with the power to design and implement its own organizational structure and staffing pattern taking into consideration its service requirements and financial capability, subject to the minimum standards and regulations prescribed by the Civil Service Commission (Sec. 76, RA 7160);

WHEREAS, Section 18 of the same code empowers the LGU to generate and utilize resources, including the authority to create positions, as long as funding is available and the action aligns with the general welfare of its constituents;

WHEREAS, Section 325(a) ensures that the creation of new positions does not exceed the 45% personnel services limitation for municipalities, thereby maintaining fiscal sustainability;
