RESOLUTION APPROVING MUNICIPAL ORDINANCE NO. 2024-13-F OF THE MUNICIPALITY OF CALATRAVA CREATING THE POSITIONS OF SOCIAL WELFARE OFFICER 1, SG 11 AND SOCIAL WELFARE AIDE 1, SG 4 IN THE MUNICIPAL SOCIAL WELFARE AND DEVELOPMENT OFFICE

WHEREAS, thereby presented for review and appropriate action of the Sangguniang Panlalawigan is Municipal Ordinance No. 2024-13-F of the Municipality of Calatrava creating the positions of Social Welfare Officer 1, SG 11 and Social Welfare Aide 1, SG 4 in the Municipal Social Welfare and Development Office;

WHEREAS, Section 56 (a) of the 1991 Local Government Code provides that within three (3) days after the approval, the secretary to the sanggunian shall forward to the sangguniang panlalawigan for review, copies of approved ordinances and resolutions approving the local development plans and public investment program formulated by the local development councils;

WHEREAS, a review of the subject ordinance reveals that the same is within the power of the Sangguniang Bayan of the Municipality of Calatrava to enact and in accordance with the Section 16 or the General Welfare Clause of R.A. 7160, otherwise known as the Local Government Code of 1991, as well as Section 76 of the same code which grants LGUs the authority to crate positions necessary for the efficient delivery of public services, provided they comply with the budgetary service requirements;

WHEREAS, in view of the foregoing, the SP Committee on Human Resource recommends approval of the same;
