WHEREAS, thereby presented for review and appropriate action of the Sangguniang Panlalawigan is Resolution No. 2024-1500 of the City of Victorias, Negros Occidental, approving the 2024 Supplemental Annual Investment Program No. 4 of Victorias City, Negros Occidental;


