RESOLUTION APPROVING APPROPRIATION ORDINANCE NO. 2024-05 OF THE MUNICIPALITY OF BINALBAGAN, NEGROS OCCIDENTAL, COVERING THE FY 2024 GENERAL FUND SUPPLEMENTAL BUDGET NO. 4 OF THE SAID MUNICIPALITY IN THE AMOUNT OF SIX MILLION NINE HUNDRED THOUSAND PESOS (P6,900,000.00)

WHEREAS, thereby presented to the Board for review and appropriate action is the FY 2024 General Fund Supplemental Budget No. 4 of the Municipality of Binalbagan, Negros Occidental with a total appropriation of Six Million Nine Hundred Thousand Pesos (P6,900,000.00), enacted by the Sangguniang Panlungsod of the said municipality per Appropriation Ordinance No. 2024-05;

WHEREAS, the above-mentioned budget shows apparent compliance in substance with the provisions of R.A. 7160, otherwise known as the Local Government Code of 1991, Budget Operations Manual for Local Government Units, 2023 Edition and implementing circulars and other issuances, as pre-reviewed and endorsed by the Provincial Budget Office and the Local Finance Committee;


THE SANGGUNIANG PANLALAWIGAN RESOLVED, as it hereby resolves, to approve Appropriation Ordinance No. 2024-05 of the Municipality of Binalbagan, Negros Occidental, and considered operative in its entirety, subject to the posting requirement under Section 59 of the Local Government Code of 1991 and further subject to the condition that the utilization of 5% Local Disaster Risk Reduction and Management Fund shall be in accordance with Rule 18 of the Implementing Rules and Regulations of Republic Act No. 10121, Commission on Audit Circular No. 2012-02 dated September 12, 2012 and National Disaster Risk Reduction and Management Council-Department of Budget and Management-Department of Interior and Local Government Joint Memorandum Circular No. 2013-1 dated March 25, 2013. Furthermore, the Local Disaster Risk and Reduction Management Plan of the municipality should be reviewed by the Office of the Civil Defense pursuant to Section 9(e) of Republic Act No. 10121.

RESOLVED FURTHER, that the accuracy of the statements/certifications and other supporting documents contained in this supplemental budget as well as observance with other existing laws, rules and regulations shall be the responsibility of the municipal government.

ADOPTED UNANIMOUSLY.

This resolution shall take effect immediately upon approval.
