WHEREAS, thereby presented to the Board for appropriate action is Appropriation Ordinance No. 03, Series of 2024 of the Municipality of San Enrique, Negros Occidental entitled: “An Appropriation Ordinance approving the CY 2024 proposed Supplemental Budget No. 3 of the Municipality of San Enrique, Negros Occidental in the amount of Two Million Six Hundred Thousand Pesos (P2,600,000.00)”;

WHEREAS, the pre-review shows apparent compliance with the same law and its Implementing Rules and Regulations, Budget Operations Manual for Local Government Units, 2023 Edition and with implementing circulars and other issuances;

This resolution shall take effect immediately upon approval.


