**RESOLUTION APPROVING APPROPRIATION ORDINANCE NO. 2024-07 OF THE MUNICIPALITY OF CALATRAVA, NEGROS OCCIDENTAL, COVERING THE 2024 GENERAL FUND SUPPLEMENTAL BUDGET NO. 5 OF THE SAID MUNICIPALITY IN THE AMOUNT OF FIVE MILLION NINE HUNDRED FORTY ONE THOUSAND THREE HUNDRED PESOS (P5,941,300.00)**

**WHEREAS**, thereby presented for review and appropriate action of the Sangguniang Panlalawigan is the 2024 General Fund Supplemental Budget No. 5 of the Municipality of Calatrava, Negros Occidental with a total appropriation of P5,941,300.00, enacted by the Sanggunian Bayan per Appropriation Ordinance No. 2024-07;

**WHEREAS**, the above-mentioned budget shows apparent compliance in substance with the provisions of R.A.
