RESOLUTION APPROVING APPROPRIATION ORDINANCE NO. 2024-07, OF THE MUNICIPALITY OF HINOBA-AN, NEGROS OCCIDENTAL APPROVING THE 2024 GENERAL FUND SUPPLEMENTAL BUDGET NO. 6 OF THE SAID MUNICIPALITY IN THE TOTAL AMOUNT OF ONE HUNDRED TWENTY SEVEN MILLION FIVE HUNDRED FORTY FIVE THOUSAND PESOS (P127,545,000.00)

WHEREAS, thereby presented to the Board for review and appropriate action is the Appropriation Ordinance No. 2024-07, of the Municipality of Hinoba-an, Negros Occidental for the 2024 General Fund Supplemental Budget No. 6 of the said municipality in the amount of One Hundred Twenty Seven Million Five Hundred Forty Five Thousand Pesos (P127,545,000.00) that was submitted to the Sangguniang Panlalawigan on December 17, 2024;

WHEREAS, the above-mentioned budget shows apparent compliance in substance with the provisions of R.A 7160, otherwise known as the Local Government Code of 1991, CY 2016 Updated Budget Operations Manual for Local Government Units, implementing circulars and other issuances as pre-reviewed and endorsed by the Local Finance Committee through the Provincial Budget Office;

WHEREAS, in view of the foregoing, the SP Committee on Finance recommends approval of the same;

THE SANGGUNIANG PANLALAWIGAN RESOLVED, as it hereby resolves, to approve Appropriation Ordinance No. 2024-07, of the Municipality of Hinoba-an, Negros Occidental for the 2024 General Fund Supplemental Budget No. 6 of the said municipality in the amount of One Hundred Twenty Seven Million Five Hundred Forty Five Thousand Pesos (P127,545,000.00) subject to the following conditions:

1. The grant of the Collective Negotiation Agreement Incentive (CNAI) for FY 2024 shall be subject to the guidelines of Budget Circular No. 2024-4, particularly on Sections 4.1.1 and 4.1.2(d), dated November 11, 2024 of the Department of Budget and Management.
2. The grant of the Productivity Enhancement Incentive (PEI) for FY 2024 shall be subject to the provisions of Circular Letter No. 2024-17 dated December 4, 2024 of the Department of Budget and Management;
3. The disbursement of the appropriation for Other Personnel Benefits shall strictly be in accordance with the existing laws/issuances on compensation and benefits, subject to Personal Services Limitation under Section 325(a) of the 1991 Local Government Code.

RESOLVED FURTHER, that the accuracy of the statements/certifications and other supporting documents contained in this supplemental budget as well as observance with the existing laws, rules and regulations shall be the responsibility of the city government.

ADOPTED UNANIMOUSLY.

This resolution shall take effect immediately upon approval.
