***RESOLUTION AUTHORIZING THE GOVERNOR TO SIGN, FOR AND IN BEHALF OF THE PROVINCE, THE CONSULTANCY AGREEMENT TO BE ENTERED INTO BY AND BETWEEN THE PROVINCE OF NEGROS OCCIDENTAL AND MR. OLIVER CHAN GOKI RELATIVE TO THE ENGAGEMENT OF HIS SERVICES AS CONSULTANT FOR WATER SUPPLY SYSTEM AND PLUMBING WORKS FOR THE PERIOD JANUARY 1, 2025 TO DECEMBER 31, 2025 FOR A MONTHLY FEE OF TWENTY FIVE THOUSAND PESOS (P25,000.00)***

***WHEREAS***, thereby presented to the Board for review and appropriate action is the request of the Governor for authority to sign, for and in behalf of the Province, the Consultancy Agreement to be entered into by and between the Province of Negros Occidental and Mr. Oliver Chan Goki relative to the engagement of his services as Consultant for Water Supply System and Plumbing Works for the period January 1, 2025 to December 31, 2025 for a monthly fee of Twenty Five Thousand Pesos (P25,000.00);

***WHEREAS***, the terms of the Consultancy Agreement are highly advantageous to the province, as Mr. Goki's specialized expertise and extensive experience in water supply system and plumbing works will significantly contribute to the efficient and effective implementation of the Provincial Government of Negros Occidental's programs;
