RELATIVE TO THE ENGAGEMENT OF HIS SERVICES AS CONSULTANT FOR MECHANICAL ENGINEERING WORKS WITH A MONTHLY FEE OF TWENTY-FIVE THOUSAND PESOS (P25,000.00) FOR THE PERIOD JANUARY 1, 2025 TO DECEMBER 31, 2025



This resolution shall take effect immediately upon approval.


