***RESOLUTION AUTHORIZING THE GOVERNOR TO SIGN, FOR AND IN BEHALF OF THE PROVINCE, THE CONSULTANCY AGREEMENT TO BE ENTERED INTO BY AND BETWEEN THE PROVINCE OF NEGROS OCCIDENTAL AND ENGR. DEAH H. DERLA RELATIVE TO THE ENGAGEMENT OF HER SERVICES AS CONSULTANT FOR LAND SURVEYING AND GEODETIC ENGINEERING FOR THE PERIOD JANUARY 1, 2025 TO DECEMBER 31, 2025 FOR A MONTHLY FEE OF THIRTY THOUSAND PESOS (P30,000.00)***

This resolution shall take effect immediately upon approval.

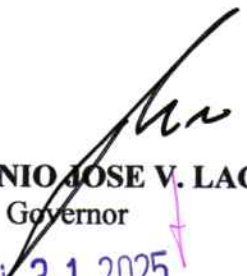
