RESOLUTION AUTHORIZING THE GOVERNOR TO SIGN, FOR AND IN BEHALF OF THE PROVINCE THE MEMORANDUM OF AGREEMENT TO BE ENTERED INTO BY AND BETWEEN THE PROVINCE OF NEGROS OCCIDENTAL AND THE SOUTH HEALTH CLINIC LABORATORY RELATIVE TO THE REFERRAL OF PATIENTS OF THE LORENZO D. ZAYCO DISTRICT HOSPITAL NEEDING LABORATORY, CT SCAN AND ULTRASOUND PROCEDURES TO BE REFERRED TO THE SAID CENTER SUBJECT TO CORRESPONDING FEES FROM JANUARY 1, 2025 – DECEMBER 31, 2025

WHEREAS, thereby presented for appropriate action of the Board is the request for authority to the Provincial Governor to sign, for and in behalf of the province the Memorandum of Agreement to be entered into by and between the Province of Negros Occidental and the South Health Clinic Laboratory relative to the referral of patients of the Lorenzo D. Zayco District Hospital needing Laboratory, CT Scan and Ultrasound procedures to be referred to the said center subject to corresponding fees from January 1, 2025 – December 31, 2025;

WHEREAS, Lorenzo D. Zayco District Hospital, a Level I government hospital needs the services of a licensed CT Scan and Ultrasound clinic diagnostic center as its referral for CT Scan and ultrasound requirements of patients;

WHEREAS, the South Health Clinical Laboratory is a licensed facility and is willing to serve as the referral CT Scan and Ultrasound clinic of Lorenzo D. Zayco District Hospital;

WHEREAS, the South Health Clinical Laboratory shall serve as the referral laboratory of LDZDH from the period January 1, 2025 – December 31, 2025 which could be renewed by the parties under such terms and conditions mutually acceptable;

WHEREAS, all referrals to the South Health Clinic Laboratory shall be charged with corresponding fees to be paid for by the patients; however patients under Philhealth No Balance Billing Policy for indigent patients (NBB), shall be shouldered by the Province;

WHEREAS, in view of the foregoing, the SP Committee on Health, finding the same to be in order, deemed it best to approve the same;

NOW THEREFORE, on motion of Hon. Araceli T. Somosa, duly seconded by all the members present,

THE SANGGUNIANG PANLALAWIGAN RESOLVED, as it hereby resolves, to authorize the Provincial Governor to sign, for and in behalf of the province the Memorandum of Agreement to be entered into by and between the Province of Negros Occidental and the South Health Clinic Laboratory relative to the referral of patients of the Lorenzo D. Zayco District Hospital needing Laboratory, CT Scan and Ultrasound procedures to be referred to the said center subject to corresponding fees from January 1, 2025 – December 31, 2025.

This resolution shall take effect immediately upon approval.


