RESOLUTION APPROVING RESOLUTION NO. 2024-270 OF THE MUNICIPALITY OF CALATRAVA APPROVING THE 5-YEAR BUSINESS PLAN OF THE MARKETS AND SLAUGHTERHOUSE UNDER THE ECONOMIC ENTERPRISE OF THE MUNICIPALITY OF CALATRAVA, NEGROS OCCIDENTAL

WHEREAS, thereby presented for review and appropriate action of the Sangguniang Panlalawigan is Resolution No. 2024-270 of the Municipality of Calatrava, Negros Occidental entitled: "Resolution approving the 5-Year Business Plan of the Markets and Slaughterhouse under the Economic Enterprise of the Municipality of Calatrava";

WHEREAS, Section 56 (a) of the 1991 Local Government Code provides that within three (3) days after the approval, the secretary to the sanggunian shall forward to the sangguniang panlalawigan for review, copies of approved ordinances and resolutions approving the local development plans and public investment program formulated by the local development councils;

WHEREAS, a review of the subject resolution reveals that the same is within the power of the Sangguniang Bayan of the Municipality of Calatrava to enact and in accordance with the Section 56 of R.A. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Municipality of Calatrava however is reminded that plan did not provide exact presentation of the projected revenue and income considering the sources based on demand and supply analysis (i.e. number of stalls available for rent, rates, other fees and target clients. It should include the technical aspect where compliance to environmental standards are needed such

as effluent disposal, proper solid waste and blood disposal, waste treatment and drainage. The previous endorsements advised the proponent to make a five-year comprehensive Income Statement and Statement of Financial Position (Balance Sheet) to present the financial condition of the venture in the coming years and include the project internal rate of return to determine its viability. To ensure the viability and sustainability of the proposed ventures as presented in the Business Plan, the Economic Enterprise Development of the Municipality of Calatrava is advised to seek assistance from the technical experts;

WHEREAS, in view of the foregoing, the SP Committee on Finance recommends approval of the same,


NOW THEREFORE, on motion of Hon. Rommel T. Debulgado, unanimously seconded by all members present,
