
RESOLUTION APPROVING RESOLUTION NO. 149, SERIES OF 2024 OF THE MUNICIPALITY OF MANAPLA, NEGROS OCCIDENTAL, APPROVING THE 2024 SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM OF THE MUNICIPALITY OF MANAPLA, NEGROS OCCIDENTAL FOR THE PURCHASE OF BACKHOE AS ENDORSED BY THE EXECUTIVE COMMITTEE MUNICIPAL DEVELOPMENT COUNCIL IN ITS RESOLUTION NO. 01, SERIES OF 2024

WHEREAS, thereby presented for review and appropriate action of the Sangguniang Panlalawigan is Resolution No. 149, Series of 2024 of the Municipality of Manapla, Negros Occidental, approving the 2024 Supplemental Annual Investment Program of the Municipality of Manapla, Negros Occidental for the purchase of backhoe as endorsed by the Executive Committee Municipal Development Council in its Resolution No. 01, Series of 2024;

WHEREAS, Section 56 (a) of the 1991 Local Government Code provides that within three (3) days after the approval, the secretary to the sanggunian shall forward to the sangguniang panlalawigan for review, copies of approved ordinances and resolutions approving the local development plans and public investment program formulated by the local development councils;

WHEREAS, a review of the subject resolution reveals that the same is within the power of the Sangguniang Bayan of the Municipality of Manapla to enact and in accordance with the pertinent provisions of R.A. 7160, otherwise known as the Local Government Code of 1991 and the said PPAs were approved by the Municipal Development Council;
