RESOLUTION APPROVING CITY ORDINANCE NO. 2024-012 OF THE CITY OF HIMAMAYLAN REVERTING THE TOTAL AMOUNT OF P20,350,000.00 FROM THE FY 2024 ALLOWABLE UNOBLIGATED BALANCES ON PS AND MOOE TO SAVINGS FOR THE GRANT OF CNA INCENTIVE AND SRI TO QUALIFIED GOVERNMENT EMPLOYEES FY 2024

WHEREAS, thereby presented for review and appropriate action of the Sangguniang Panlalawigan is City Ordinance No. 2024-012 of the City of Himamaylan reverting the total amount of P20,350,000.00 from the FY 2024 allowable unobligated balances on PS and MOOE to savings for the grant of CNA Incentive and SRI to qualified government employees FY 2024;

WHEREAS, Section 56 (a) of the 1991 Local Government Code provides that within three (3) days after the approval, the secretary to the sanggunian shall forward to the sangguniang panlalawigan for review, copies of approved ordinances and resolutions approving the local development plans and public investment program formulated by the local development councils;

WHEREAS, a review of the subject resolution reveals that the same is within the power of the Sangguniang Panlungsod of the Himamaylan to enact pursuant to Section 322 of R.A. 7160, otherwise known as the Local Government Code of 1991 and Article 454 (b)(1) of its Implementing Rules and Regulations;

WHEREAS, in view of the foregoing, the SP Committee on Finance recommends approval of the same;


