
***RESOLUTION DECLARING ORDINANCE NO. 24-28 OF THE CITY OF SAN CARLOS, NEGROS OCCIDENTAL, AMENDING ORDINANCE NO. 23-18 OF THE SAID CITY, AS A VALID ENACTED ORDINANCE***

**WHEREAS**, Section 56 of the Local Government Code of 1991 expresses the reviewing power of the Sangguniang Panlalawigan on Component City and Municipal Ordinances and Resolutions declaring the Ordinance or Resolution valid if it is consistent with the law or invalid in whole or in part if the Sangguniang Panlalawigan finds the Ordinance or Resolution to be beyond the power conferred upon the Sangguniang Panlungsod or Sangguniang Bayan concerned;

**WHEREAS**, Ordinance No. 24-28 of the City of San Carlos, Negros Occidental, entitled: "**AMENDATORY ORDINANCE OF ORDINANCE NO. 23-18, BY ADOPTING SPECIFIC REVISIONS OF THE SCHEDULE OF MARKET VALUES FOR THE 2023 GENERAL REVISION OF REAL PROPERTY ASSESSMENT OF REAL PROPERTIES LOCATED IN THE CITY OF SAN CARLOS, NEGROS OCCIDENTAL**" was submitted for review by the City of San Carlos to the Sangguniang Panlalawigan of Negros Occidental;

**WHEREAS**, after prompt examination by the Provincial Legal Office, it is the recommendation of the said Office that the subject Ordinance is within the conferred power of the Sangguniang Panlungsod of San Carlos to enact, thus, the same may be given due course by the Sangguniang Panlalawigan;

**WHEREAS**, the subject ordinance is pursuant and complies with Sections 56, 236, 237 and 59 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;
