RESOLUTION APPROVING APPROPRIATION ORDINANCE NO. 05, SERIES OF 2024 OF THE MUNICIPALITY OF ILOG, COVERING THE FY 2024 SUPPLEMENTAL BUDGET NO. 4 OF THE SAID MUNICIPALITY IN THE AMOUNT OF THREE MILLION EIGHT HUNDRED TEN THOUSAND PESOS (P3,810,000.00)

WHEREAS, thereby presented to the Board for review and appropriate action is the FY 2024 Supplemental Budget No. 4 of the Municipality of Ilog, Negros Occidental with a total appropriation of Three Million Eight Hundred Ten Thousand Pesos (P3,810,000.00), enacted by the Sangguniang Bayan per Appropriation Ordinance No. 05, Series of 2024;

WHEREAS, the above-mentioned budget shows apparent compliance in substance with the provisions of R.A. 7160, otherwise known as the Local Government Code of 1991, Budget Operations Manual for Local Government Units, 2023 Edition and implementing circulars and other issuances, as pre-reviewed and endorsed by the Provincial Budget Office and the Local Finance Committee;

WHEREAS, in view of the foregoing, the SP Committee on Budget and Finance recommends approval of the same,

NOW, THEREFORE, on motion of Hon. Rommel T. Debulgado and unanimously seconded by all the members present,

THE SANGGUNIANG PANLALAWIGAN RESOLVED, as it hereby resolves, to approve and declare operative in its entirety effective December 19, 2024 the Appropriation Ordinance No. 05, Series of 2024 of the Municipality of Ilog, Negros Occidental, subject to the following requirements/conditions:


1. Posting requirement under Section 59 of the Local Government Code (LGC) of 1991;
2. The grant of Collective Negotiation Agreement Incentive (CNAI) for FY 2024 shall be subject to the guidelines of Budget Circular No. 2024-4, particularly on Sections 4.1.1 and 4.1.2 (d), dated November 11, 2024 of the Department of Budget and Management;
3. The Section 54 of the LGC provides that every ordinance enacted by the Sangguniang Bayan shall be presented to the municipal mayor, as the case may be, If the Local Chief Executive concerned approves the same, he shall affix his signature on each and every page thereof.

RESOLVED FURTHER, that the accuracy of the statement/certification and other supporting documents contained in this supplemental budget as well as observance with other existing laws, rules and regulations shall be the responsibility of the municipal government.

This resolution shall take effect immediately upon approval.
