

RESOLUTION APPROVING APPROPRIATION ORDINANCE NO. 06, SERIES OF 2024 OF THE MUNICIPALITY OF HINIGARAN, NEGROS OCCIDENTAL COVERING THE FY 2024 GENERAL FUND SUPPLEMENTAL BUDGET NO. 5 OF THE SAID MUNICIPALITY AMOUNTING TO ONE HUNDRED NINETY MILLION PESOS (₱190,000,000.00) AND SUPPLEMENTAL BUDGET NO. 01 UNDER ECONOMIC ENTERPRISE AMOUNTING TO ONE MILLION THREE HUNDRED THOUSAND PESOS (₱1,300,000.00)

WHEREAS, thereby presented for review and appropriate action of the Sangguniang Panlalawigan is the FY 2024 General Fund Supplemental Budget No. 5 of the Municipality of Hinigaran, Negros Occidental, with a total appropriation of One Hundred Ninety Million Pesos (₱190,000,00.00) and Supplemental Budget No. 01 under Economic Enterprise amounting to One Million Three Hundred Thousand Pesos (₱1,300,000.00) enacted by the Sangguniang Bayan per Appropriation Ordinance No. 06, Series of 2024;

WHEREAS, the above-mentioned budget shows apparent compliance with the same law, its Implementing Rules and Regulations, Budget Operations Manual for Local Government Units, 2023 Edition and implementing circulars and other issuances;

WHEREAS, upon review of the Local Finance Committee, said Appropriation Ordinance is recommended for approval and considered operative in its entirety on December 12, 2024 subject to the posting requirements under Section 59 of Local Government Code of 1991 and subject to the condition that the purchase and specification of the motor vehicles shall be subject to the provisions of Administrative Order No. 14 dated December 10, 2018; Budget Circular (BC) No. 2022-1 dated February 11, 2022 and BC No. 2022-1A dated March 1, 2023 of the Department of Budget and Management (DBM);

NOW THEREFORE, on motion of Hon. Rommel T. Debulgado, unanimously seconded by all the members present,


