WHEREAS, thereby presented to the Board for appropriate action is Appropriation Ordinance No. 06, Series of 2024 of the Municipality of San Enrique, Negros Occidental entitled: “AN APPROPRIATION ORDINANCE APPROVING THE CY 2024 PROPOSED SUPPLEMENTAL BUDGET NO. 5 OF THE MUNICIPALITY OF SAN ENRIQUE, NEGROS OCCIDENTAL IN THE AMOUNT OF ONE MILLION EIGHT HUNDRED FOUR THOUSAND PESOS (P1,804,000.00)”;

NOW THEREFORE, on motion of Hon. Rommel T. Debulgado, unanimously seconded by all the members present;


