WHEREAS, thereby presented to the Board for review and appropriate action is the FY 2024 General Fund Supplemental Budget No. 2 of the Municipality of Murcia, Negros Occidental with a total appropriation of Eight Million Two Hundred Thousand Pesos (P8,200,000.00), enacted by the Sangguniang Bayan per Appropriation Ordinance No. 3, Series of 2023;


1. Posting requirements under Section 59 of the Local Government Code of 1991;
2. Indicate the proper Annual Investment Program (AIP) reference codes under the column three (3) of Local Budget Preparation Form No. 9. The AIP Reference Code is vital to ensuring the Plan-Budget Linkage. The code assigned to each PPA facilitates validation of whether or not the PPAs funded in the budget are the same PPAs prioritized in the AIP.

RESOLVED FURTHER, that the accuracy of the statement/certification and other supporting documents contained in this supplemental budget as well as observance with other existing laws, rules and regulations shall be the responsibility of the municipal government.
