RESOLUTION APPROVING APPROPRIATION ORDINANCE NO. 05, SERIES OF 2024 OF THE MUNICIPALITY OF ISABELA, NEGROS OCCIDENTAL, COVERING THE 2024 GENERAL FUND SUPPLEMENTAL BUDGET NO. 4 OF THE SAID MUNICIPALITY IN THE AMOUNT OF THREE MILLION THREE HUNDRED TEN THOUSAND ONE HUNDRED SIXTY EIGHT PESOS AND SIXTY TWO CENTAVOS (P3,310,168.62)

WHEREAS, thereby presented for review and appropriate action of the Sangguniang Panlalawigan is the 2024 General Fund Supplemental Budget No. 4 of the Municipality of Isabela, Negros Occidental with a total appropriation of P3,310,168.62, enacted by the Sanggunian Bayan per Appropriation Ordinance No. 05, series of 2024;

WHEREAS, the above-mentioned budget shows apparent compliance in substance with the provisions of R.A. No. 7160, otherwise known as the Local Government Code of 1991, and Joint Circular No. 93-2 of the Commission on Audit and the Department of Budget and Management dated June 8, 1993 and other implementing circulars and issuances, as pre-reviewed and endorsed by the Provincial Budget Officer and the Local Finance Committee;

WHEREAS, in view of the foregoing, the SP Committee on Budget and Finance recommends approval of the same;

THE SANGGUNIANG PANLALAWIGAN RESOLVED, as it hereby resolves, to approve Appropriation Ordinance No. 05, series of 2024 of the Municipality of Isabela covering the 2024 General Fund Supplemental Budget No. 4 of the said municipality with a total appropriation of P3,310,168.62 and considered operative in its entirety effective November 29, 2024, subject to the posting requirement under Section 59 of LGC 1991 and subject further to the conditions and reminders:

1. The disbursement of Donations shall be solely for public purposes and subject to Section 36 and 305(b), 335 and 351 of the LGC of 1991 and shall be under the general supervision of the Local Chief Executive per Section 455 of the said law;
2. the utilization of the Local Disaster Risk Reduction and Management Fund shall be in accordance with the IRR of RA 10121 and its IRR, COA Circular No. 2012-02 dated September 12, 2012 and NDRRMC-DBM-DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013; and
3. the Gender and Development (GAD) Plan and Budget shall be prepared pursuant to RA 7192, RA 9710 and Philippine Commission on Women-DILG-DBM-NEDA JMC No. 2016-01 dated January 12, 2016 and that the same shall be reviewed and endorsed by the DILG;

RESOLVED FURTHER, that the accuracy of the statement/certification and other supporting documents contained in this supplemental budget as well as the observance with other existing laws, rules and regulations shall be the responsibility of the municipal government.

ADOPTED UNANIMOUSLY.

This resolution shall take effect immediately upon approval.
