THE SANGGUNIANG PANLALAWIGAN RESOLVED, as it hereby resolves, to approve and declare operative in its entirety the Appropriation Ordinance No. 007, Series of 2024 of the Municipality of Manapla, Negros Occidental, subject to the posting requirement under Section 59 of the Local Government Code (LGC) of 1991, and further subject to the following conditions and reminders:

1. The grant of the Service Recognition Incentive (SRI) to government employees for FY 2024 must be in accordance with the provisions of Budget Circular No. 2024-7 dated December 16, 2024 of the Department of Budget and Management;
2. That Section 56 in relation with Section 326 of the LGC provides that within three (3) days after approval of the Ordinance authorizing annual/supplemental appropriation, the Secretary to the Sanggunian shall forward the said Ordinance to the appropriate reviewing authority.

RESOLVED FURTHER, that the accuracy of the statements/certifications and other supporting documents contained in this supplemental budget as well as observance with other existing laws, rules and regulations and compliance with the existing laws, rules and regulations shall be the responsibility of the municipal government.

This resolution shall take effect immediately upon approval.
