RESOLUTION AUTHORIZING THE PROVINCIAL GOVERNOR TO SIGN, FOR AND IN BEHALF OF THE PROVINCE, THE DEED OF DONATION TO BE EXECUTED BY THE PROVINCE OF NEGROS OCCIDENTAL IN FAVOR OF H.O.P.E. VOLUNTEERS FOUNDATION, INC. RELATIVE TO THE DONATION OF ONE (1) UNIT OF PROJECTOR (EPSON EB-E01 3300 LUMENS) IN THE AMOUNT OF TWENTY THOUSAND NINE HUNDRED FIFTY PESOS (P20,950.00)

WHEREAS, the request from Governor Eugenio Jose “Bong” Lacson, dated December 13, 2024, has been forwarded to the Sangguniang Panlalawigan, for authority to sign, for and in behalf of the Province, the Deed of Donation between the Province of Negros Occidental and H.O.P.E. Volunteers Foundation, Inc.;

WHEREAS, the Province of Negros Occidental intends to donate to H.O.P.E. Volunteers Foundation, Inc. one (1) unit of Projector (Epson EB-E01 3300 Lumens) in the amount of Twenty Thousand Nine Hundred Fifty Pesos (P20,950.00);

WHEREAS, the document is aligned with the R.A. 7160 of the Local Government Code especially under the General Welfare Clause, to wit:

Section 16. General Welfare. - Every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare. territorial jurisdictions, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, enhance the right of the people to a balanced ecology, encourage and support the development of appropriate and self-reliant scientific and technological capabilities, improve public morals, enhance economic prosperity and social justice, promote full employment among their residents, maintain peace and order, and preserve the comfort and convenience of their inhabitants.

This resolution shall take effect immediately upon approval.


