RESOLUTION GRANTING AUTHORITY TO THE PROVINCIAL GOVERNOR, TO SIGN FOR AND ON BEHALF OF THE PROVINCE, THE DEED OF DONATION TO BE EXECUTED BY THE PROVINCE OF NEGROS OCCIDENTAL AND THE UNIVERSITY OF ST. LA SALLE, INC. RELATIVE TO THE DONATION OF VARIOUS EQUIPMENTS FOR THE USE OF THE UNIVERSITY

WHEREAS, the request from Gov. Eugenio Jose “Bong” Lacson, dated December 13, 2024, has been forwarded to the Sangguniang Panlalawigan concerning the Deed of Donation between the between the Province of Negros Occidental and municipalities of Hinoba-an and Cauayan;

WHEREAS, the Province of Negros Occidental intends to donate the following items to the LGUs: one (1) unit projector (Epson EB-E01 3300 Lumens) to the H.O.P.E. Volunteers Foundation, Inc. for its use, and various equipment to the University of St. La Salle, Inc. for the university's use, as part of the endorsement from the Governor requesting authority to sign the respective deeds of donation;

WHEREAS, the Document is aligned with the R.A. 7160 otherwise of the Local Government Code especially under the General Welfare Clause, to wit:

Section 16. General Welfare. - Every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare. respective territorial jurisdictions, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, enhance the right of the people to a balanced ecology, encourage and support the development of appropriate and self-reliant scientific and technological capabilities, improve public morals, enhance economic prosperity and social justice, promote full employment among their residents, maintain peace and order, and preserve the comfort and convenience of their inhabitants.

WHEREAS, in view of the foregoing, the SP Committee on Laws recommends approval of the same;

NOW THEREFORE, on motion of Hon. Sixto Teofilo Roxas V. Guanzon, Jr., unanimously seconded by all the members present;

THE SANGGUNIANG PANLALAWIGAN RESOLVED, as it hereby resolves, to grant authority to the Provincial Governor to sign for and on behalf of the province, the Deed of Donation to be executed by the Province of Negros Occidental and the University of St. La Salle, Inc. relative to the donation of various equipments for the use of the university.

This resolution shall take effect immediately upon approval.


