ORDINANCE NO. 003

AN ORDINANCE RECLASSIFYING THE VACANT POSITION OF PSYCHOLOGIST II, SALARY GRADE 15 TO PSYCHOLOGIST I, SALARY GRADE 16 UNDER THE PROVINCIAL HUMAN RESOURCE MANAGEMENT OFFICE OF THE PROVINCE OF NEGROS OCCIDENTAL

BE IT ENACTED, by the Sangguniang Panlalawigan of Negros Occidental in its Regular Session duly assembled that:

SECTION 1. RECLASSIFICATION OF VACANT POSITION. – One vacant position of Psychologist II, Salary Grade 15 is hereby reclassified to Psychologist I, Salary Grade 16 under the Provincial Human Resource Management Office of the Province of Negros Occidental.

SECTION 2. PERSONNEL SCHEDULE. – The existing Personnel Schedule of the Provincial Human Resource Management Office of the Province of Negros Occidental is hereby revised and adopted, as shown in Annex “A” of this Ordinance.

SECTION 4. SEPARABILITY CLAUSE. – If for any reason, any provision, section or part of this ordinance is declared not valid by a government agency or a court of competent jurisdiction, such judgment shall not affect the other sections or provisions of this ordinance, which shall continue to be in full force and effect.

SECTION 5. REPEALING CLAUSE. – All ordinances, resolutions, rules and regulations, or parts thereof which are inconsistent with any of the provisions of this ordinance are hereby repealed, amended or modified accordingly.
