RELATIVE TO THE SHARED COMMITMENT OF BOTH PARTIES TO IMPROVING HEALTHCARE ACCESSIBILITY, ENSURING EFFICIENT MEDICAL SERVICES AND PROMOTING PUBLIC WELFARE
