RESOLUTION AUTHORIZING THE GOVERNOR TO SIGN, FOR AND IN BEHALF OF THE PROVINCE THE MEMORANDUM OF AGREEMENT TO BE ENTERED INTO BY AND BETWEEN THE PROVINCE OF NEGROS OCCIDENTAL AND NATIONAL UNIVERSITY (NU) BACOLOD INCORPORATED RELATIVE TO THE IMPLEMENTATION OF THE "ACCELERATING THE MISSION OF LEARNING AND INCLUSIVE GROWTH" (AMLIG) PROGRAM, A SCHOLARSHIP PROGRAM OF THE PROVINCE WHICH PROVIDES EDUCATIONAL OPPORTUNITIES TO DESERVING STUDENTS IN NEGROS OCCIDENTAL

WHEREAS, thereby presented for appropriate action of the Board is the request for authority to the Provincial Governor to sign, for and in behalf of the province the Memorandum of Agreement to be entered into by and between the Province of Negros Occidental and National University (NU) Bacolod Incorporated relative to the implementation of the "Accelerating the Mission of Learning and Inclusive Growth" (AMLIG) Program of the province which provides educational opportunities to deserving students in Negros Occidental;
