RESOLUTION APPROVING MUNICIPAL ORDINANCE NO. 2024-288 OF THE MUNICIPALITY OF CAUAYAN, NEGROS OCCIDENTAL, CREATING VARIOUS POSITIONS FOR OFFICES AFFECTED BY DEVOLVED PROGRAMS AND SERVICES IN THE SAID MUNICIPALITY

WHEREAS, Section 56 of the Local Government Code of 1991 expresses the reviewing power of the Sangguniang Bayan on Component City and Municipal Ordinances and Resolutions declaring the Ordinance or Resolution valid if it is consistent with the law or invalid in whole or in part if the Sangguniang Panlalawigan finds the Ordinance or Resolution to be beyond the power conferred upon the Sangguniang Panlangsod or Sangguniang Bayan concerned;
