**RESOLUTION APPROVING ORDINANCE NO. 25-394 OF THE CITY OF ESCALANTE CREATING THE POSITION OF MEDICAL OFFICER III UNDER THE CITY HEALTH OFFICE AND ALLOCATING BUDGET FOR THE PURPOSE**

**WHEREAS**, thereby presented for review and appropriate action of the Sangguniang Panlalawigan is Ordinance No. 25-394 of the City of Escalante creating the position of Medical Officer III under the City Health Office and allocating budget for the purpose;

**WHEREAS**, Section 56 (a) of the 1991 Local Government Code provides that within three (3) days after the approval, the secretary to the sanggunian shall forward to the sangguniang panlalawigan for review, copies of approved ordinances and resolutions approving the local development plans and public investment program formulated by the local development councils;

**WHEREAS**, a review of the subject ordinance reveals that the same is within the power of the Sangguniang Panlungsod of the City of Escalante to enact and in accordance with the Section 76 and Section 458(2)(1)(viii) of R.A. 7160, otherwise known as the Local Government Code of 1991, as well as Section 16 of the General Welfare Clause of the same code;

**WHEREAS**, in view of the foregoing, the SP Committee on Human Resource recommends approval of the same;

**NOW, THEREFORE**, on motion of Hon. Rommel T. Debulgado, unanimously seconded by all the members present,

**THE SANGGUNIANG PANLALAWIGAN RESOLVED**, as it hereby resolves, to approve Ordinance No. 25-394 of the City of Escalante creating the position of Medical Officer III under the City Health Office and allocating budget for the purpose.
