RESOLUTION AUTHORIZING THE GOVERNOR TO SIGN, FOR AND IN BEHALF OF THE PROVINCE, THE CONSULTANCY AGREEMENT TO BE ENTERED INTO BY AND BETWEEN THE PROVINCE OF NEGROS OCCIDENTAL AND DR. RANE T. MONTINOLA RELATIVE TO THE ENGAGEMENT OF HIS SERVICES AS CONSULTANT ON ANESTHESIOLOGY AT THE VALLADOLID DISTRICT HOSPITAL FOR THE PERIOD JANUARY 1, 2025 TO DECEMBER 31, 2025

WHEREAS, thereby presented to the Board for review and appropriate action is the request of the Governor for authority to sign, for and in behalf of the Province, the Consultancy Agreement to be entered into by and between the Province of Negros Occidental and Dr. Rane T. Montinola relative to the engagement of his services as Consultant on Anesthesiology at the Valladolid District Hospital for the period January 1, 2025 to December 31, 2025;

WHEREAS, under said Consultancy Agreement, the province shall pay Dr. Montinola the sum of Thirty Thousand Pesos (P30,000.00) per month in consideration of his services rendered as consultant at the Valladolid District Hospital;
