RESOLUTION AUTHORIZING THE PROVINCIAL GOVERNOR TO SIGN, FOR AND IN BEHALF OF THE PROVINCE, THE CONSULTANCY AGREEMENT TO BE ENTERED INTO BY AND BETWEEN THE PROVINCE OF NEGROS OCCIDENTAL AND DR. ANGELICA J. LOZADA RELATIVE TO THE ENGAGEMENT OF HER SERVICES AS JUNIOR CONSULTANT AT THE CADIZ DISTRICT HOSPITAL FOR THE PERIOD JANUARY 1, 2025 TO DECEMBER 31, 2025

WHEREAS, thereby presented for appropriate action of the Sangguniang Panlalawigan of the Province of Negros Occidental is the Consultancy Agreement to be entered into by and between the Province of Negros Occidental and Dr. Angelica J. Lozada relative to the engagement of her services as Junior Consultant at the Cadiz District Hospital for the period January 1, 2025 to December 31, 2025;

WHEREAS, under the said agreement, Dr. Lozada shall render not less than and not more than Twenty Four (24) hours per tour of duty and shall not exceed eight (8) duties per month with the rate of P8,000.00/24-hours duty;

WHEREAS, the Committee on Health, finding the subject agreement to be favorable and all the necessary documents to be in order, deemed it best to approve the same;
