RESOLUTION AUTHORIZING THE GOVERNOR TO SIGN, FOR AND IN BEHALF OF THE PROVINCE, THE CONSULTANCY AGREEMENT TO BE ENTERED INTO BY AND BETWEEN THE PROVINCE OF NEGROS OCCIDENTAL AND DR. ALLEN JOHN N. JAMITO RELATIVE TO THE ENGAGEMENT OF HIS SERVICES AS JUNIOR CONSULTANT AT THE MERCEDITAS J. MONTILLA DISTRICT HOSPITAL FOR THE PERIOD JANUARY 1, 2025 TO DECEMBER 31, 2025


WHEREAS, thereby presented to the Board for review and appropriate action is the request of the Governor for authority to sign, for and in behalf of the Province, the Consultancy Agreement to be entered into by and between the Province of Negros Occidental and Dr. Allen John M. Jamito relative to the engagement of his services as Junior Consultant at the Merceditas J. Montilla District Hospital for the period January 1, 2025 to December 31, 2025;

WHEREAS, under said Consultancy Agreement, Dr. Jamito shall render not less than and not more than twenty four (24) hours per tour of duty and shall not exceed eight (8) duties per month and shall receive a rate of Eight Thousand Pesos (P8,000.00) per 24-hours duty;

WHEREAS, in view of the foregoing, the SP Committee on Health recommends approval of the same;
