ALFREDO C. LIM, JR. RELATIVE TO THE ENGAGEMENT OF HIS SERVICES AS JUNIOR CONSULTANT AT THE MERCEDITAS J. MONTILLA DISTRICT HOSPITAL FOR THE PERIOD OF JANUARY 1, 2025 TO DECEMBER 31, 2025 WITH A MONTHLY RATE OF EIGHT THOUSAND PESOS (\$\frac{P}{2}\$,000.00) PER 24-HOUR DUTY
