WHEREAS, thereby presented to the Board for appropriate action of the Sangguniang Panlalawigan is the request of the Governor for authority to sign for and on behalf of the province, the Consultancy Agreement to be entered into by and between the Province of Negros Occidental and Dr. Ritze Rose E. Germinal relative to the engagement of her services as Radiologist at the PHO-Lorenzo D. P50.00 for Simple Procedures, additional of P30.00 for additional views/patient
P250.00 for Upper Gi Series-6pcs films
P250.00 for Barium Enema-7pcs films
P250.00 for Barium Swallow (Esophagogram)- 4pcs films
P35.00 for IVP- 7pcs films
30% of Tariff of Ultrasound Procedure
