GATUSLAO MEMORIAL DISTRICT HOSPITAL, VALLADOLID DISTRICT HOSPITAL, IGNACIO L. ARROYO SR. MEMORIAL DISTRICT HOSPITAL, MERCEDITAS J. MONTILLA DISTRICT HOSPITAL AND ELEUTERIO T. DECENA MEMORIAL HOSPITAL FOR THE PERIOD JANUARY 1, 2025 – DECEMBER 31, 2025

WHEREAS, Ordinance No. 004, series of 2008 allows private doctors, consultants and other technical experts to practice in the Provincial Government owned hospital (s);

WHEREAS, the Province of Negros Occidental needs to hire a Radiologist for the various hospitals of the Province of Negros Occidental to provide professional expertise in the medical evaluation and reading of X-ray films for a more efficient delivery of services and to maintain its accreditation with the PhilHealth Insurance Corporation and Department of Health License to operate;

WHEREAS, the Province have contracted the services of Dr. Jeanette C. King, FPCR as Radiologist of the various hospitals under the following given rates:

WHEREAS, the Consultancy Agreement is in order and conforms to the requirements on the law of contracts;

WHEREAS, in view of the foregoing, the SP Committee on Health deemed it best to approve the same;

NOW THEREFORE, on motion of Hon. Araceli T. Somosa, unanimously seconded by all the members present,

THE SANGGUNIANG PANLALAWIGAN RESOLVED, as it hereby resolves, to approve the Consultancy Agreement to be entered into by and between the Province of Negros Occidental and Dr. Jeanette C. King relative to the engagement of her services as Radiologist at the various hospitals of the Province of Negros Occidental for the period of January 1, 2025 – December 31, 2025.

RESOLVED FURTHER, to grant authority to the Provincial Governor to sign, for and in behalf of the province, the said Consultancy Agreement and the Provincial Treasurer to release the fund in accordance therewith.
