RESOLUTION AUTHORIZING THE PROVINCIAL GOVERNOR TO SIGN, FOR AND IN BEHALF OF THE PROVINCE, THE CONSULTANCY AGREEMENT TO BE ENTERED INTO BY AND BETWEEN THE PROVINCE OF NEGROS OCCIDENTAL AND DR. JAMIELYNN ANNE F. CRUZ-NALUMEN RELATIVE TO THE ENGAGEMENT OF HER SERVICES AS CONSULTANT-PATHOLOGIST AT THE VARIOUS HOSPITALS OF THE PROVINCE FOR THE PERIOD OF JANUARY 1, 2025 TO DECEMBER 31, 2025

WHEREAS, thereby presented to the Board for review and appropriate action is the request of the Governor for authority to sign, for and in behalf of the Province, the Consultancy Agreement to be entered into by and between the Province of Negros Occidental and Dr. Jamielynn Anne F. Cruz-Nalumen relative to the engagement of her services as Consultant-Pathologist at the various hospitals of the province for the period of January 1, 2025 to December 31, 2025;

WHEREAS, hospitals to serve include Valladolid District Hospital, Ignacio L. Arroyo, Sr. Memorial District Hospital and Merceditas Montilla District Hospital with a basic monthly rate of Twenty Thousand Pesos \$\mathbb{P}\$20,000.00 per hospital as indicated in the agreement;
