RESOLUTION APPROVING AND CONCURRING WITH RESOLUTION NO. 08, SERIES OF 2024 OF THE PROVINCIAL HEALTH BOARD OF NEGROS OCCIDENTAL APPROVING THE PROPOSED BUDGET FOR 2025 FY AS PRESENTED TO THE PROVINCIAL HEALTH BOARD AND RECOMMENDING ITS ADOPTION IN COMPLIANCE WITH THE GUIDELINES OF THE DBM AND PROVISIONS OF RA NO. 7160 OF THE LOCAL GOVERNMENT CODE OF 1991

WHEREAS, Section 106 of RA 7160, otherwise known as the Local Government Code of 1991 provides that “each LGU shall have a comprehensive multi-sectoral development plan to be initiated by its development councils and approved by its sanggunian”;

WHEREAS, Section 114 of the said code further provides that the plans, programs and projects proposed by the local development council shall be submitted to the sanggunian concerned for appropriate action;

WHEREAS, thereby presented for review and appropriate action of the Sangguniang Panlalawigan is Resolution No. 08, series of 2024 of the Provincial Health Board of Negros Occidental approving the proposed budget for 2025 FY as presented to the Provincial Health Board and recommending its adoption in compliance with the guidelines of the DBM and provisions of RA No. 7160 of the Local Government Code of 1991;
