RESOLUTION APPROVING AND CONCURRING WITH RESOLUTION NO. 08, SERIES OF 2024 OF THE PROVINCIAL HEALTH BOARD OF NEGROS OCCIDENTAL APPROVING THE PROPOSED BUDGET FOR 2025 FY AS PRESENTED TO THE PROVINCIAL HEALTH BOARD AND RECOMMENDING ITS ADOPTION IN COMPLIANCE WITH THE GUIDELINES OF THE DBM AND PROVISIONS OF RA NO. 7160 OF THE LOCAL GOVERNMENT CODE OF 1991

WHEREAS, thereby presented for review and appropriate action of the Sangguniang Panlalawigan is Resolution No. 08, series of 2024 of the Provincial Health Board of Negros Occidental approving the proposed budget for 2025 FY as presented to the Provincial Health Board and recommending its adoption in compliance with the guidelines of the DBM and provisions of RA No. 7160 of the Local Government Code of 1991;
