**RESOLUTION APPROVING APPROPRIATION ORDINANCE NO. 2024-06 OF THE MUNICIPALITY OF LA CASTELLANA, NEGROS OCCIDENTAL, COVERING THE 2024 GENERAL FUND SUPPLEMENTAL BUDGET NO. 5 OF THE SAID MUNICIPALITY IN THE AMOUNT OF TWO MILLION SIX HUNDRED SIX THOUSAND TWO HUNDRED EIGHTEEN PESOS AND SEVENTY TWO CENTAVOS (P2,606,218.72)**

**WHEREAS**, thereby presented for review and appropriate action of the Sangguniang Panlalawigan is the 2024 General Fund Supplemental Budget No. 5 of the Municipality of La Castellana, Negros Occidental with a total appropriation of P2,606,218.72, enacted by the Sanggunian Bayan per Appropriation Ordinance No. 2024-06;

**WHEREAS**, the above-mentioned budget shows apparent compliance in substance with the provisions of R.A. No. 7160, otherwise known as the Local Government Code of 1991, and Joint Circular No. 93-2 of the Commission on Audit and the Department of Budget and Management dated June 8, 1993 and other implementing circulars and issuances, as pre-reviewed and endorsed by the Provincial Budget Officer and the Local Finance Committee;

**THE SANGGUNIANG PANLALAWIGAN RESOLVED**, as it hereby resolves, to approve Appropriation Ordinance No. 2024-06 of the Municipality of La Castellana covering the 2024 General Fund Supplemental Budget No. 5 of the said municipality with a total appropriation of P2,606,218.72 and considered operative in its entirety effective December 16, 2024 subject to the posting requirement under Section 59 of LGC 1991 and the following conditions:

1. The un-appropriated balance in the amount of P2,850,000.00 shall not be disbursed except by subsequent enactment of an Appropriation Ordinance; and
2. The disbursement of Donation s shall be used solely for public purposes and subject to Section 56 and 305(b) of the LGC of 1991.

**RESOLVED FURTHER**, that the accuracy of the statement/certification and other supporting documents contained in this supplemental budget as well as the observance with other existing laws, rules and regulations shall be the responsibility of the municipal government.
