RESOLUTION APPROVING APPROPRIATION ORDINANCE NO. 2024-06 OF THE MUNICIPALITY OF LA CASTELLANA, NEGROS OCCIDENTAL, COVERING THE 2024 GENERAL FUND SUPPLEMENTAL BUDGET NO. 5 OF THE SAID MUNICIPALITY IN THE AMOUNT OF TWO MILLION SIX HUNDRED SIX THOUSAND TWO HUNDRED EIGHTEEN PESOS AND SEVENTY TWO CENTAVOS (P2,606,218.72)

WHEREAS, thereby presented for review and appropriate action of the Sangguniang Panlalawigan is the 2024 General Fund Supplemental Budget No. 5 of the Municipality of La Castellana, Negros Occidental with a total appropriation of P2,606,218.72, enacted by the Sanggunian Bayan per Appropriation Ordinance No. 2024-06;

WHEREAS, the above-mentioned budget shows apparent compliance in substance with the provisions of R.A. No. 7160, otherwise known as the Local Government Code of 1991, and Joint Circular No. 93-2 of the Commission on Audit and the Department of Budget and Management dated June 8, 1993 and other implementing circulars and issuances, as prereviewed and endorsed by the Provincial Budget Officer and the Local Finance Committee;

WHEREAS, in view of the foregoing, the SP Committee on Budget and Finance recommends approval of the same;

THE SANGGUNIANG PANLALAWIGAN RESOLVED, as it hereby resolves, to approve Appropriation Ordinance No. 2024-06 of the Municipality of La Castellana covering the 2024 General Fund Supplemental Budget No. 5 of the said municipality with a total appropriation of P2,606,218.72 and considered operative in its entirety effective December 16, 2024 subject to the posting requirement under Section 59 of LGC 1991 and the following conditions:

- 1. The un-appropriated balance in the amount of P2,850,000.00 shall not be disbursed except by subsequent enactment of an Appropriation Ordinance; and
- 2. The disbursement of Donation s shall be used solely for public purposes and subject to Section 56 and 305(b) of the LGC of 1991.

RESOLVED FURTHER, that the accuracy of the statement/certification and other supporting documents contained in this supplemental budget as well as the observance with other existing laws, rules and regulations shall be the responsibility of the municipal government.

This resolution shall take effect immediately upon approval.
