RESOLUTION APPROVING APPROPRIATION ORDINANCE NO. 02, SERIES OF 2024 OF THE MUNICIPALITY OF PULUPANDAN, NEGROS OCCIDENTAL ENTITLED: “AN ORDINANCE AUTHORIZING SUPPLEMENTAL BUDGET NO. 2024-1, SERIES OF 2024 INVOLVING AN AMOUNT OF FIVE MILLION TWENTY-EIGHT THOUSAND ONE HUNDRED NINETY-FOUR PESOS (P5,028,194.00) FOR VARIOUS EXPENDITURES OF THE MUNICIPALITY OF PULUPANDAN”

WHEREAS, thereby presented to the Board for appropriate action of the Sangguniang Panlalawigan is Appropriation Ordinance No. 02, Series of 2024 of the Municipality of Pulupandan, Negros Occidental entitled: “An Ordinance authorizing Supplemental Budget No. 2024-1, Series of 2024 involving an amount of Five Million Twenty-Eight Thousand One Hundred Ninety-Four Pesos (P5,028,194.00) for various expenditures of the Municipality of Pulupandan”;

WHEREAS, the pre-review shows apparent compliance with the same law, its Implementing Rules and Regulations, Budget Operations Manual, 2023 Edition for Local Government Units, implementing circulars and other issuances;

WHEREAS, the same is recommended for approval and declared operative in its entirety effective December 18, 2024 subject to the posting requirements under Section 59 of LGC and shall further be subject to the following conditions:

Page 2, Resolution No. 0313, Series of 2025

1. *The utilization of the 20% Development Fund shall be utilized and disbursed in accordance with the provisions of Joint Memorandum Circular (JMC) No. 1 of the DBM, DOF, and DILG dated November 4, 2020 and consistent with the approved Annual Investment Plan (AIP) and/or Supplemental Annual Investment Plan (SAIP);*
2. *The utilization of Local Disaster Risk Reduction and Management Fund shall be in accordance with R.A. No. 10121 and its Implementing Rules and Regulations, COA Circular No. 2012-02 dated September 12, 2012 and NDRRMC-DBM-DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013;*
3. *The Gender and Development (GAD) Plan and Budget shall be prepared pursuant to R.A. No. 7192, RA No. 9710, and Philippine Commission on Women-DILG-DBM-National Economic and Development Authority JMC No. 2016-01 dated January 12, 2016, and the same shall be reviewed and endorsed by the Department of the Interior and Local Government (DILG);*
4. *Strict adherence in the period as to the submission of Appropriation Ordinances to the Sangguniang Panlalawigan for review per Section 56(1) of RA 7160, which states that: "Review of Component City and Municipal Ordinances or Resolutions by the Sangguniang Panlalawigan – (a) Within three(3) days after approval, the secretary to the Sanggunian Panlungsod or Sangguniang Bayan shall forward to the Sangguniang Panlalawigan for review, copies of approved ordinances and the resolutions approving the local development plans and public investment programs formulated by the local development councils; and*
5. *The Local Chief Executive (LCE), upon approving the AO, shall sign in every page thereof pursuant to Section 54(a) of the LGC, which provides that, "every ordinance enacted by the sangguniang panlalawigan, sangguniang panlungsod, or sangguniang bayan shall be presented to the provincial governor or city or municipal mayor, as the case may be. If the LCE concerned approved the same, he shall affix his signature on each and every page.*

WHEREAS, in view of the foregoing, the SP Committee on Finance recommends approval of the same;

NOW THEREFORE, on motion of Hon. Rommel T. Debulgado, unanimously seconded by all the members present;

THE SANGGUNIANG PANLALAWIGAN RESOLVED, as it hereby resolves, to approve Appropriation Ordinance No. 02, Series of 2024 of the Municipality of Pulupandan, Negros Occidental entitled: "An Ordinance authorizing Supplemental Budget No. 2024-1, Series of 2024 involving an amount of Five Million Twenty-Eight Thousand One Hundred Ninety-Four Pesos (P5,028,194.00) for various expenditures of the Municipality of Pulupandan";
