RESOLUTION APPROVING APPROPRIATION ORDINANCE NO. 05, SERIES OF 2024 OF THE CITY OF VICTORIAS, NEGROS OCCIDENTAL, COVERING THE 2024 GENERAL FUND SUPPLEMENTAL BUDGET NO. 4 OF THE SAID CITY IN THE AMOUNT OF SIXTY NINE MILLION FIVE HUNDRED THOUSAND PESOS (P69,500,000.00)

WHEREAS, thereby presented for review and appropriate action of the Sangguniang Panlalawigan is the 2024 General Fund Supplemental Budget No. 4 of the City of Victorias, Negros Occidental with a total appropriation of P69,500,000.00, enacted by the Sanggunian Panlungsod per Appropriation Ordinance No. 05, series of 2024;

WHEREAS, the above-mentioned budget shows apparent compliance in substance with the provisions of R.A. No. 7160, otherwise known as the Local Government Code of 1991, and Joint Circular No. 93-2 of the Commission on Audit and the Department of Budget and Management dated June 8, 1993 and other implementing circulars and issuances, as pre-reviewed and endorsed by the Provincial Budget Officer and the Local Finance Committee;

WHEREAS, in view of the foregoing, the SP Committee on Budget and Finance recommends approval of the same;

THE SANGGUNIANG PANLALAWIGAN RESOLVED, as it hereby resolves, to approve Appropriation Ordinance No. 05, series of 2024 of the City of Victorias covering the 2024 General Fund Supplemental Budget No. 4 of the said municipality with a total appropriation of P69,500,000.00 and considered operative in its entirety effective November 14, 2024 subject to the posting requirement under Section 59 of LGC 1991 and the following conditions and reminders:

1. the utilization of the Local Disaster Risk Reduction and Management Fund shall be in accordance with RA 10121 and its IRR, COA Circular No. 2012-02 dated September 12, 2012 and NDRRMC-DBM-DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013;
2. the purchase and specifications of the motor vehicles shall be subject to the provisions of Administrative Order No. 14, dated December 10, 2018; BC No. 2022-1 dated February 11, 2022 and BC No. 2022-1A dated March 1, 2023 of the DBM;
3. the payment of honorarium to city government personnel involved in government procurement shall be in accordance with the provisions of DBM Budget Circular Nos. 2004-5A and 2007-3 dated October 7, 2005 and November 29, 2007, respectively; and
4. strict adherence in the period as to the submission of Appropriation Ordinances to the Sangguniang Panlalawigan for review per Section 56(a) of RA 7160 which states that: "Review of Component Cities and Municipal Ordinances or Resolutions by the Sangguniang Panlalawigan - (a) within three (3) days after approval, the Secretary to the Sangguniang Panlungsod or Sangguniang Bayan shall forward to the Sangguniang Panlalawigan for review, copies of approved ordinances and resolutions approving local development plans and public investment programs formulated by the local development councils".

RESOLVED FURTHER, that the accuracy of the statement/certification and other supporting documents contained in this supplemental budget as well as the observance with other existing laws, rules and regulations shall be the responsibility of the city government.

ADOPTED UNANIMOUSLY.

This resolution shall take effect immediately upon approval.
