RESOLUTION ADOPTING JOINT MEMORANDUM CIRCULAR NO. 2021-0001 ISSUED BY THE DEPARTMENT OF HEALTH (DOH), DEPARTMENT OF FINANCE (DOF), DEPARTMENT OF BUDGET AND MANAGEMENT (DBM), DEPARTMENT OF INTERIOR AND LOCAL GOVERNMENT (DILG) AND PHILHEALTH PROVIDING GUIDELINES ON THE ALLOCATION, UTILIZATION, MONITORING, AND ACCOUNTABILITY OF THE SPECIAL HEALTH FUND (SHF) UNDER THE UNIVERSAL HEALTH CARE ACT"

WHEREAS, thereby presented to the Board for appropriate action is the indorsement of the Governor requesting for the passage of a resolution entitled: "A Resolution adopting Joint Memorandum Circular No. 2021-0001 issued by the Department of Health (DOH), Department of Budget and Management (DBM), Department of Finance (DoF) Department of Interior and Local Government (DILG) and Philhealth providing guidelines on the allocation, utilization, monitoring, and accountability of the Special Health Fund (SHF) under the Universal Health Care Act";

WHEREAS, Republic Act No. 11223, otherwise known as the Universal Health Care Act (UHC) Act, mandates the integration of local health systems into Province-Wide and City-Wide Health Systems (P/CWHS) and the pooling of financial resources intended for health services into a Special Health Fund (SHF);

WHEREAS. Joint Memorandum Circular No. 2021-0001, issued by the DOH, DBM, DoF, DILG and Philhealth providing guidelines on the allocation, utilization, monitoring, and accountability of the Special Health Fund (SHF) under the Universal Health Care Act";
