RESOLUTION AUTHORIZING THE GOVERNOR TO SIGN FOR AND IN BEHALF OF THE PROVINCE THE CONSULTANCY AGREEMENT TO BE ENTERED INTO BY AND BETWEEN THE PROVINCE OF NEGROS OCCIDENTAL AND DR. WENDELL Z. ESPINOSA RELATIVE TO THE ENGAGEMENT OF HIS SERVICES AS CONSULTANT ON GASTROENTEROLOGY AT THE TERESITA L. JALANDONI PROVINCIAL HOSPITAL FOR THE PERIOD JANUARY 1, 2025 – DECEMBER 31, 2025

WHEREAS, thereby presented to the Board for review and appropriate action is the request of the Governor for the approval and authority to sign the Consultancy Agreement to be entered into by and between the Province of Negros Occidental and Dr. Wendell Z. Espinosa relative to the engagement of his services as Consultant on Gastroenterology at the Teresita L. Jalandoni Provincial Hospital for the period of January 1, 2025 – December 31, 2025;

WHEREAS, Ordinance No. 004, series of 2008 allows private doctors, consultants and other technical experts to practice in the Provincial Government owned hospital (s);

WHEREAS, the Provincial Government of Negros Occidental and more particularly the Teresita L. Jalandoni Provincial Hospital, Silay City, a government hospital under its administration is in need of the services of a duly licensed Doctor of Medicine, Certified in Gastroenterology, to provide services not performed by the regular personnel of Teresita L. Jalandoni Provincial Hospital;

WHEREAS, the Province have contracted the services of Dr. Wendell Z. Espinosa as Consultant on Gastroenterology for the amount of Thirty Thousand Pesos (P30,000.00) to be paid on a monthly basis;

WHEREAS, Dr. Espinosa shall render a minimum of four (4) visits per month in the hospital;

WHEREAS, the Consultancy Agreement is in order and conforms to the requirements on the law of contracts;

WHEREAS, in view of the foregoing, the SP Committee on Health deemed it best to approve the same;

NOW THEREFORE, on motion of Hon. Araceli T. Somosa, unanimously seconded by all the members present,

THE SANGGUNIANG PANLALAWIGAN RESOLVED, as it hereby resolves, to authorize the Governor to sign for and in behalf of the Province the Consultancy Agreement to be entered into by and between the Province of Negros Occidental and Dr. Wendell Z. Espinosa relative to the engagement of his services as Consultant on Gastroenterology at the Teresita L. Jalandoni Provincial Hospital for the period of January 1, 2025 – December 31, 2025.

RESOLVED FURTHER, to grant authority to the Provincial Treasurer to release the fund in accordance therewith.
