RESOLUTION AUTHORIZING THE GOVERNOR TO SIGN FOR AND IN BEHALF OF THE PROVINCE THE CONSULTANCY AGREEMENT TO BE ENTERED INTO BY AND BETWEEN THE PROVINCE OF NEGROS OCCIDENTAL AND DR. EMILIA G. MARAVILLA RELATIVE TO THE ENGAGEMENT OF HER SERVICES AS CONSULTANT ON ANATOMICAL PATHOLOGY AT THE TERESITA L. JALANDONI PROVINCIAL HOSPITAL FOR THE PERIOD JANUARY 1, 2025 – DECEMBER 31, 2025

WHEREAS, thereby presented to the Board for review and appropriate action is the request of the Governor for the approval and authority to sign the Consultancy Agreement to be entered into by and between the Province of Negros Occidental and Dr. Emilia G. Maravilla relative to the engagement of her services as Consultant on Anatomical Pathology at the Teresita L. Jalandoni Provincial Hospital for the period of January 1, 2025 – December 31, 2025;

WHEREAS, Ordinance No. 004, series of 2008 allows private doctors, consultants and other technical experts to practice in the Provincial Government owned hospital (s);

WHEREAS, the Provincial Government of Negros Occidental and more particularly the Teresita L. Jalandoni Provincial Hospital, Silay City, a government hospital under its administration is in need of the services of a duly licensed Doctor of Medicine in the field of Anatomical Pathology, who shall head and oversee the operations of the histopathology section;

WHEREAS, the Province have contracted the services of Dr. Emilia G. Maravilla as Consultant on Anatomical Pathology for the amount of Thirty Thousand Pesos (P30,000.00) to be paid on a monthly basis;
