RESOLUTION AUTHORIZING THE PROVINCIAL GOVERNOR TO SIGN, FOR AND IN BEHALF OF THE PROVINCE, THE CONSULTANCY AGREEMENT TO BE ENTERED INTO BY AND BETWEEN THE PROVINCE OF NEGROS OCCIDENTAL AND DR. APRIL SANCHEZ-GARCIA RELATIVE TO THE ENGAGEMENT OF HER SERVICES AS CONSULTANT IN NEPHROLOGY AT THE TERESITA L. JALANDONI PROVINCIAL HOSPITAL FOR THE PERIOD OF JANUARY 1, 2025 TO DECEMBER 31, 2025

WHEREAS, thereby presented to the Board for review and appropriate action is the request of the Governor for authority to sign, for and in behalf of the Province, the Consultancy Agreement to be entered into by and between the Province of Negros Occidental and Dr. April Sanchez-Garcia relative to the engagement of her services as Consultant in Nephrology at the Teresita L. Jalandoni Provincial Hospital for the period of January 1, 2025 to December 31, 2025;

WHEREAS, as stated in the said agreement, for consideration of her services, the province shall pay Thirty Thousand Pesos (₱30,000.00) to be paid on monthly basis;

WHEREAS, in view of the foregoing, the SP Committee on Health recommends approval of the same;
