***RESOLUTION AUTHORIZING THE GOVERNOR TO SIGN, FOR AND IN BEHALF OF THE PROVINCE, THE CONSULTANCY AGREEMENT TO BE ENTERED INTO BY AND BETWEEN THE PROVINCE OF NEGROS OCCIDENTAL AND DR. LENI MONTES RELATIVE TO THE ENGAGEMENT OF HER SERVICES AS CONSULTANT ON GENERAL PATHOLOGY AT THE TERESITA L. JALANDONI PROVINCIAL HOSPITAL FOR THE PERIOD JANUARY 1, 2025 TO DECEMBER 31, 2025***

***WHEREAS***, thereby presented to the Board for review and appropriate action is the request of the Governor for authority to sign, for and in behalf of the Province, the Consultancy Agreement to be entered into by and between the Province of Negros Occidental and Dr. Leni Montes relative to the engagement of her services as Consultant on General Pathology at the Teresita L. Jalandoni Provincial Hospital for the period January 1, 2025 to December 31, 2025;

***WHEREAS***, under said agreement, the province shall pay Dr. Montes the sum of Thirty Thousand Pesos (P30,000.00) per month in consideration of the services performed as Clinical Pathologist and Head of the Laboratory Department by conducting a minimum of four (4) regular visits every month in said hospital;

***WHEREAS***, in view of the foregoing, the SP Committee on Health recommends approval of the same;


