RESOLUTION AUTHORIZING THE GOVERNOR TO SIGN, FOR AND IN BEHALF OF THE PROVINCE, THE CONSULTANCY AGREEMENT TO BE ENTERED INTO BY AND BETWEEN THE PROVINCE OF NEGROS OCCIDENTAL AND DR. DOLORES ROMMELA TIPLES-RUIZ RELATIVE TO THE ENGAGEMENT OF HER SERVICES AS CONSULTANT ON INFECTIOUS DISEASES AT THE TERESITA L. JALANDONI PROVINCIAL HOSPITAL FOR THE PERIOD JANUARY 1, 2025 TO DECEMBER 31, 2025

WHEREAS, thereby presented to the Board for review and appropriate action is the request of the Governor for authority to sign, for and in behalf of the Province, the Consultancy Agreement to be entered into by and between the Province of Negros Occidental and Dr. Dolores Rommela Tipples-Ruiz relative to the engagement of her services as Consultant on Infectious Diseases at the Teresita L. Jalandoni Provincial Hospital for the period January 1, 2025 to December 31, 2025;

WHEREAS, under said agreement, the province shall pay Dr. Tipples-Ruiz the sum of Thirty Thousand Pesos (P30,000.00) per month in consideration of the services performed as Consultant/Adviser of the Infection Control and Antimicrobial Stewardship Committee by rendering a minimum of four (4) visits per month in said hospital;

WHEREAS, in view of the foregoing, the SP Committee on Health recommends approval of the same;
