***RESOLUTION AUTHORIZING THE GOVERNOR TO SIGN, FOR AND IN BEHALF OF THE PROVINCE, THE CONSULTANCY AGREEMENT TO BE ENTERED INTO BY AND BETWEEN THE PROVINCE OF NEGROS OCCIDENTAL AND DR. SHERWIN LOWE B. RODRIGO RELATIVE TO THE ENGAGEMENT OF HIS SERVICES AS CONSULTANT ON SURGERY AT THE TERESITA L. JALANDONI PROVINCIAL HOSPITAL FOR THE PERIOD JANUARY 1, 2025 TO DECEMBER 31, 2025***

***WHEREAS***, thereby presented to the Board for review and appropriate action is the request of the Governor for authority to sign, for and in behalf of the Province, the Consultancy Agreement to be entered into by and between the Province of Negros Occidental and Dr. Sherwin Lowe B. Rodrigo relative to the engagement of his services as Consultant on Surgery at the Teresita L. Jalandoni Provincial Hospital for the period January 1, 2025 to December 31, 2025;

***WHEREAS***, under said agreement, the province shall pay Dr. Rodrigo the sum of Thirty Thousand Pesos (P30,000.00) per month in consideration of the services rendered as Hepatobiliary Surgery Consultant by receiving, managing, answering referrals at least four (4) times a month in the said hospital;

***WHEREAS***, in view of the foregoing, the SP Committee on Health recommends approval of the same;
