RESOLUTION AUTHORIZING THE PROVINCIAL GOVERNOR TO SIGN, FOR AND IN BEHALF OF THE PROVINCE, THE CONSULTANCY AGREEMENT TO BE ENTERED INTO BY AND BETWEEN THE PROVINCE OF NEGROS OCCIDENTAL AND DR. KATHRYN KRISTY P. BAUTISTA RELATIVE TO THE ENGAGEMENT OF HER SERVICES AS CONSULTANT ON OBSTETRICS AND GYNECOLOGY AT THE TERESITA L. JALANDONI PROVINCIAL HOSPITAL FOR THE PERIOD JANUARY 1, 2025 TO DECEMBER 31, 2025

WHEREAS, thereby presented for appropriate action of the Sangguniang Panlalawigan of the Province of Negros Occidental is the Consultancy Agreement to be entered into by and between the Province of Negros Occidental and Dr. Kathryn Kristy P. Bautista relative to the engagement of her services as Consultant on Obstetrics and Gynecology at the Teresita L. Jalandoni Provincial Hospital for the period January 1, 2025 to December 31, 2025;

WHEREAS, under the said agreement, Dr. Bautista shall render services as Perinatologic Consultant who shall receive, manage and answer referrals of some high risk cases at least twice a month at the Teresita L. Jalandoni Provincial Hospital and in consideration for the services performed, the province shall pay her a monthly sum of Ten Thousand Pesos (P10,000.00);

WHEREAS, the Committee on Health, finding the subject agreement to be favorable and all the necessary documents to be in order, deemed it best to approve the same;
