RESOLUTION AUTHORIZING THE GOVERNOR TO SIGN, FOR AND IN BEHALF OF THE PROVINCE THE CONSULTANCY AGREEMENT TO BE ENTERED INTO BY AND BETWEEN THE PROVINCE OF NEGROS OCCIDENTAL AND RM APRIL T. ALON, RPSY RELATIVE TO THE ENGAGEMENT OF HER SERVICES AS CONSULTANT PSYCHOLOGIST AT THE PROVINCIAL HEALTH OFFICE FOR THE PERIOD JANUARY 1, 2025 – DECEMBER 31, 2025

WHEREAS, thereby presented to the Board for review and appropriate action is the request of the Governor for the approval and authority to sign the Consultancy Agreement to be entered into by and between the Province of Negros Occidental and RM April T. Alon, RPsy relative to the engagement of her services as Consultant Psychologist at the Provincial Health Office for the period of January 1, 2025 – December 31, 2025;

WHEREAS, Ordinance No. 004, series of 2008 allows private doctors, consultants and other technical experts to practice in the Provincial Government owned hospital (s);

WHEREAS, the Provincial Government of Negros Occidental needs to hire a Consultant Psychologist to provide professional expertise in the mental health services of the Province of Negros Occidental;

WHEREAS, the Province have contracted the services of RM April T. Alon, RPsy as Consultant on Psychology with an honorarium in the amount of Forty Two Thousand Six Hundred Fifty Two Pesos (P42,652.00);
